

Change in management of FREQUENTIS Comsoft as of May 2021: Constantin von Reden to succeed Thomas Hoffmann

After two years of successful expansion work at Frequentis Comsoft, an essential software company of the Frequentis Group for the ATM and Defence sectors, Thomas Hoffmann will hand over the management agendas to Constantin von Reden, currently Vice President ATC/AD at Rohde & Schwarz GmbH & Co. KG, as of May 2021.

Frequentis Comsoft is an important member of the Frequentis Group. The complementary product portfolio in the field of air traffic management ensures Frequentis' market leadership in message handling systems (MHS) and in AIM. Likewise, the Frequentis Comsoft Surveillance Systems for the civil and military ATM sector are an important addition to the portfolio.

The focus of Thomas Hoffmann's management activities in the past two years was on the further integration of Frequentis Comsoft into the Frequentis Group, on product development, and on the further development of sales. Cross-group integrated solutions are offered on the ATM market worldwide.

Thomas Hoffmann now wants to leave the Frequentis Group at the end of 2021 to take on a new professional challenge. To ensure a smooth transition, he will hand over the management of the company to Constantin v. Reden effective 1 May 2021 and will then be available to the Frequentis Executive Board and his successor in an advisory capacity until the end of 2021.

With Constantin v. Reden, another ATM professional is joining the Comsoft management. In his current role as Vice President Market Segment ATC at Rohde & Schwarz in Germany, Constantin v. Reden is responsible for Profit & Loss worldwide for communication systems in the areas of air traffic control, airports and air defence. Constantin v. Reden graduated in aerospace engineering and was an officer in the German Air Force, where he gained a wide range of international experience. He will start at Frequentis Comsoft on 1 April 2021 and take over as Managing Director on 1 May 2021.
