



FREQUENTIS: Slovakian Defence Minister visits company headquarters in Vienna

Appreciated visit to the Vienna headquarters of the globally operating high-tech company Frequentis: Together with a high-ranking delegation, the Slovakian Minister of Defence Jaroslav Nad' convinced himself of Frequentis' performance as a supplier of solutions for safety-critical applications. The contribution of the Slovak Frequentis subsidiary to the successful growth of the company group was also acknowledged.

The Slovakian Air Force has been a Frequentis customer for several years: Within the scope of a comprehensive modernisation programme, Frequentis is responsible for equipping the Slovakian Air Force with NATO-compliant ground-to-ground and ground-to-air communication. During the visit to the company's headquarters, Minister Nad' was now presented with the wide range of innovative Frequentis communication and information solutions in the safety-critical area.

The Slovakian defence minister was particularly impressed by the demonstrations of the Frequentis Remote Digital Tower. This software solution allows remote air traffic control at smaller airports or airports located in hazardous areas. As a deployable system, it offers quickly available solutions for setting up temporary airfields. The Frequentis Remote Digital Tower is already being used successfully by several customers worldwide.

The important contribution that the Slovakian subsidiary makes to the development of the Frequentis Group was also positively emphasised by both sides. "What started 30 years ago as a small software office in Bratislava is now a strong independent company with about 140 Slovakian employees," said Hannes Bardach, Chairman of the Supervisory Board and majority owner of Frequentis AG. Minister Nad' also emphasised the importance of being able to offer solutions with a high proportion of value added from Slovakia globally.

Today, the Frequentis Group of Companies supplies more than 500 customers worldwide, in the segments Air Traffic Management (civil and military air traffic control, air defence) and Public Safety & Transport (police, fire brigade, rescue services, shipping, railways). The Bratislava company was founded in 1991 as one of the first Frequentis subsidiaries and has made important contributions to the growth of the Group over the past 30 years.
