

FREQUENTIS AG: Transactions in connection with share repurchase programme / 1st interim announcement

Publication pursuant to Article 5 of Regulation (EU) No 596/2014 and Article 2 Para 3 of the Delegated Regulation (EU) 2016/1052.

1st interim announcement regarding the share repurchase programme for shares of Frequentis AG, ISIN: ATFREQUENT09

In the period from 28 August 2023 to 1 September 2023, Frequentis AG purchased a total of 2,514 shares within the scope of the share repurchase programme published on 17 August 2023. The total number of repurchased shares, the weighted average price, and the aggregated volume per day for the period were as follows:

Since the start of the share repurchase programme on 28 August 2023, 2,514 shares have thus been purchased. The shares were repurchased exclusively via the Vienna Stock Exchange by a bank commissioned by Frequentis AG.
