2nd interim announcement regarding the share repurchase programme for shares of Frequentis AG, ISIN: ATFREQUENT09

In the period from 04 to 08 September 2023, Frequentis AG purchased a total of 703 shares within the scope of the share repurchase programme published on 17 August 2023.
