

FREQUENTIS AG: Transactions in connection with share repurchase programme / 3rd announcement

3rd interim announcement regarding the share repurchase programme for shares of Frequentis AG, ISIN: ATFREQUENT09

In the period from 11 to 15 September 2023, Frequentis AG purchased a total of 2,833 shares within the scope of the share repurchase programme published on 17 August 2023. The total number of repurchased shares, the weighted average price, and the aggregated volume per day for the period were as follows:
