

## **FREQUENTIS AG: Transactions in connection with share repurchase programme / 4th announcement**

### **4th interim announcement regarding the share repurchase programme for shares of Frequentis AG, ISIN: ATFREQUENT09**

In the period from 18 to 22 September 2023, Frequentis AG purchased a total of 1,163 shares within the scope of the share repurchase programme published on 17 August 2023. The total number of repurchased shares, the weighted average price, and the aggregated volume per day for the period were as follows:
