

FREQUENTIS AG: Transactions in connection with share repurchase programme / 9th announcement

9th interim announcement regarding the share repurchase programme for shares of Frequentis AG, ISIN: ATFREQUENT09

In the period from 23 to 27 October 2023, Frequentis AG purchased a total of 931 shares within the scope of the share repurchase programme published on 17 August 2023. The total number of repurchased shares, the weighted average price, and the aggregated volume per day for the period were as follows:
